The location and identification of all existing and proposed easements and right-of-ways should be shown on the plan. The easements would need the approval of the township solicitor. Additionally, the 50' ROW between Mrs. Hershey and Ben Beiler shown on the plan for future use will need the Solicitor's review and approval also. Mr. Crossan will request the Planning Commission to support a waiver regarding showing existing trees with a caliper of six inches or greater on the plan at a later date.
