Working Supervisors:

All three Supervisors are affirmed to work on roads if needed; request Auditors' approval of \$12.00/hr for other road work and \$12.00/hr. for snow equipment operations. Recommend to Auditors that Supervisors be reimbursed \$ .575/mile, the current IRS rate per mile to attend Road Inspections and Seminars.

7 paid holidays – New Year's Day, Good Friday, Memorial Day, July 4<sup>th</sup>, Labor Day, Veterans Day, Thanksgiving and Christmas 6 paid sick days – may be accumulated up to 24 days

3 days for bereavement leave – immediate family and 1 day for near relative 2 personal days per year

There were no comments from the public or the Board of Supervisors regarding the above. The hearing was closed at 7:30 P.M.

## THE REGULAR MEETING WAS RESUMED AT 7:31 P.M.

ZONING – Scott Rugen read the Zoning Officer's report for the month.

ROADS –Scott Rugen read the Road Master's report for the month. Projects for the coming year were discussed; culvert @ Blanks, Widdowson Road maintenance, Willard Lane/Collamer Road culvert. The heater in the shop was broken. To replace the motor is approximately \$477.00. The Supervisors agreed to have this repaired by Alger Oil. Additionally, the propane heater in the garage was broken. The Supervisors agreed to purchase an Infrared Heater for approximately \$800.00. The Supervisors also agreed to have someone come and replace the broken fan in the ladies bathroom. The Township's Spring Trash Clean up Days will be scheduled for Friday, April 24, 2015 and Saturday, April 25, 2015.

HISTORIC COMMISSION – The Historic Commission members reported that Karen Marshall from the County has the township scheduled for August 15, 2015 for the Town Tour. Blair has contacted Andy Chalfont regarding printing the next newsletter.

PARK – Scott reported that he attended the last Park Committee's meeting. Seung Ah Byun from the Brandywine Conservancy was present and showed some design layouts. Seung will also contact Ragan Engineering regarding the park development.

EMERGENCY MANAGEMENT – a Code Red Webinar will be held Tuesday, January 6, 2015. The Supervisors plan to participate in the webinar. Discussion was held regarding the answering machine and messages if no one is in the office. The Secretary will check into this matter.

ROUTE 1 CORRIDER PLAN – Charlie reported that the Route 1 Task Force is considering writing a letter to Lower Oxford Township objecting to the Ordinance that they are considering adopting allowing for an electronic billboard.

PLANNING COMMISSION – 2014 REPORT –Presented a year end report which was read by Scott Rugen.

2015 – Charlie brought forth some ideas of discussion for 2015: A. Route 896 Task Force; B. Ordinance to allow for horses as transport; C. MS-4, to continue; D. Act 163, rules and regulations for pipelines. Item B would need to come from the Planning Commission and Item A would need to come from the Task Force. Additionally, revisiting our Ordinances to meet the Regional Comprehensive Plan. Money might be available to do this task.

OPEN SPACE GRANT – Betsy discussed with the others information from PECO regarding grants for Open Space projects. The grant is for \$10,000.00 which the township would need to match. The deadline is March 27, 2015. Scott will follow through with this.
