PUBLIC COMMENTS – There were no comments at this time from the public.

MINUTES – Motion was made by Scott Rugen, seconded by Charles Fleischmann and carried to approve the June 11, 2012 Minutes.

LINDA PIERCE – Motion was made by Scott Rugen, seconded by Charles Fleischmann and carried to adopt Resolution #2012-5 which is the Sewage Planning Module for the Linda Pierce Subdivision and Land Development Plan.

FRANCIS AND FRANCES SHARON – Two lot add-on Plan on Cheek Road. This subdivision has been processed by Lower Oxford Township and approved by both their Planning Commission and Board of Supervisors. Upper Oxford Township Planning Commission members approved this plan July 2, 2012. Motion was made by Scott Rugen, seconded by Charles Fleischmann and carried to approve and sign the Sharon add-on Plan.

Ricky also stated that he thought that there has been an increase in the dumping at the recycling area after holidays. Charlie mentioned that he would talk to his friend about the possibility of borrowing a security camera.

ZONING – Betsy read the Zoning Officer's report for the month. We will have Bill send a letter to the vacant property in Turners Pond regarding weeds.

ENGINEERING – A status report was received from the township engineer, Ron Ragan. Motion was made by Charles Fleischmann, seconded by Scott Rugen and carried designating Ron Ragan as the principal contact for the SW NPDES permit and have Ron pass along all information he receives in that capacity to the Board of Supervisors for review.
