WEBSITE – No prices have been received yet. Supervisors all agreed that they liked Option 1. Ordinances should be added to the website also.

ZONING – Scott Rugen read the Zoning Officer's report for the month.

ROADS - No report was received.

HISTORIC – Frances Reyburn reported that the newsletters have been mailed. Conservation on who owns the deed to the Hosanna Church and Amos house. Nothing resolved. Frances submitted the figures for the One Room School Plaques. The Supervisors will discuss this at their budget meeting.

EMERGENCY – Nothing to report. Discuss of new radio system in County and testing ours to be sure they are compatible. Scott said that the County radios will have no impact on our systems. They are working on finding an EOC location.

PAYMENT OF BILLS – Motion was made by Betsy Huber, seconded by Charles Fleischmann and carried to approve the payment of bills in the amount of \$47,144.64 from the General Fund and \$92,816.76 from the Open Space Fund.
