The Upper Oxford Township Board of Supervisors held their regular monthly meeting at the township building, 1185 Limestone Road, Russellville, PA at 7:00 P.M.

After the Salute to the Flag, Betsy Huber led in prayer.

PUBLIC COMMENTS – Terry Kaplan, of Planet Aid approached the Board to discuss the reasoning why the Board decided to have Goodwill place containers at the recycling area and eliminate Planet Aid containers. Scott Rugen informed Mr. Kaplan that one reason was that Goodwill was involved in Pennsylvania activities and not overseas. Another reason was that we are trying to eliminate people from illegal dumping of items at the containers. Scott told Mr. Kaplan that we plan to move our containers and recycling area to Catamount Road. At that time we will entertain the idea of re-installing Planet Aid along with Goodwill if the area can accommodate both.

KENNETT AREA SENIORS – Ken Schreffler and Tom Hoehle representing the Kennett Area Seniors discussed with the Board the various programs that Kennett Area Senior Center offers to residents. The Center provides 50 or more programs each week to seniors. Two of the programs are an independent book store and bingo every Friday evening. A new program which is being offered is Neighbors in Action which helps people through the community, such as drive seniors to appointments, grocery shopping, help with minor repairs or work around their homes, walking their dogs, reading or writing, and assistance with forms and services. There is a membership fee which is charged on a sliding scale. The Center is looking for members and also for volunteers, especially from the Oxford and Nottingham Area. Brochures will be placed on the back table with more information regarding the offered programs. The Supervisors agreed to put a link on the township website.

CHUCK FREESE – Emergency Management Coordinator – discussed with the Supervisors the OXREM. All of the surrounding townships are members now and the organization is looking into a radio repeater system. At this time, they have tentative permission to place it on the tower at Route 1 and Route 896. However, the organization is looking for a township to take ownership of the license. Motion was made by Charles Fleischmann, seconded by Betsy Huber and carried to take ownership of a license repeater funded by Oxford Regional Emergency Management.
