TAX LEVY RATE – Motion was made by Charles Fleischmann, seconded by Betsy Huber to adopt Resolution #2015 – 8, setting the millage rate for 2016 at .5 mills on each \$100 of assessed value.

This cost will be covered by a grant from the Brandywine Conservancy.

LANDOWNER/GRANTEE AGREEMENT WITH BRANDYWINE CONSERVANCY – Will be discussed next month. Scott Rugen thanked the conservancy and park committee for all their hard work and research on this matter.

ROADS – Scott Rugen read the road master's report for the month. The Supervisors will have a "sit-down" meeting with Ricky in the near future regarding snow operations for the year.

HISTORIC – Frances Reyburn reported that the Historic Commission received a copy of the report generated by Wise Preservation. Additionally, the Historic Commission is still looking for a volunteer to replace Margaret Hickman who term has expired.

ZONING – Scott Rugen read the Zoning Officer's report for the month.

EMERGENCY – Blair Fleischmann reported that the County is swapping out radios and also gave a brief summary of the OxRem's training and meetings.

PAYMENT OF BILLS – Motion was made by Betsy Huber, seconded by Charles Fleischmann and carried to approve the payment of bills in the amount of \$20,000.00 from the Open Space Fund; the amount of \$72,983.49 from the State Fund and the amount of \$35,911.69 from the General Fund.

GRIST MILL/HEAVLOW PROPERTY – A meeting will be held at the DEP office in Norristown on December 18, 2015 at 10:00 A.M. with Mr. and Mrs. Heavlow of 4 Grist Mill Lane. Scott Rugen and the township engineer, Ronald Ragan will attend this meeting. A member of the HOA Management will also be present.

SPCA CONTRACT – The Secretary will get more information regarding a contract with LaMancha and present it next month. The Supervisors have agreed to not pay the present invoice to Chester County SPCA in the amount of \$3600.00.

STORMWATER UPDATE AND ACT 537 – The township engineer, Ron Ragan will be present at our January work session to discuss these items.

VERIZON – The Supervisors agreed to switch the long distance carrier from AT&T to Verizon. The Township will be responsible for a two year contract and monthly rate will be approximately \$125.00/month. The Secretary will contact Verizon and AT&T.

GRANT – Betsy Huber explained that the County Planning Commission is applying for a grant which will require a \$2,000.00 match from each municipality. Supervisor Rugen and Fleischmann agreed to this as long as the grant benefits Upper Oxford Township and the other townships agree to this grant also.

VISTA 2025 – Charlie was invited to the vista 2025 meeting. Transportation was one items of discussion. The next meeting will be held the 2^{nd} Tuesday in January.

MIKE DeGeiso – Questioned the Supervisors on the fire company and ambulance contracts and what areas of the township each company was responsible for.
